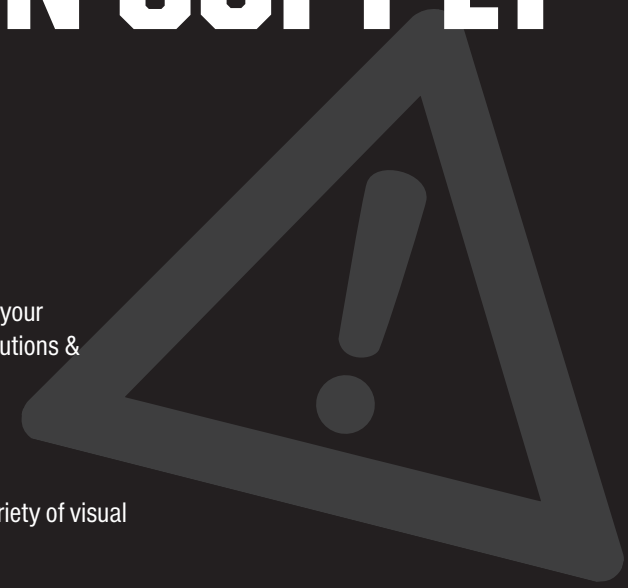

# FEE BASED TRAINING



## COMPETENT PERSON TRAINING

16 hour course; This two-day intermediate level course is designed for facility & site supervisors who must also serve as the competent person required by OSHA 1926.32(f), 1926.500 & 1910 standards. Participants are assigned tasks which require evaluation for fall hazards. The tasks are described using real-life site photos. The training provides more detailed coverage of the Fall Prevention & Protection Supervisor Training course materials & various fall protection topics. The course also supplies the participant with the knowledge & skills to perform the annual inspection & record keeping.



## OSHA 10 HOUR GENERAL INDUSTRY

Two day, 10 hour training course meets OSHA requirements. Upon successful completion of the course, participants will receive a course completion card. All participants will take a pre-test followed by class work on required & selected OSHA topics.



## OSHA 10 HOUR CONSTRUCTION

Two day, 10 hour training course meets OSHA requirements. Upon successful completion of the course, participants will receive a course completion card. All participants will take a pre-test followed by class work on required & selected OSHA topics.



## FALL PROTECTION BASIC RESCUE

16 hour course; this training course is designed for any supervisor or personnel who work at heights in construction or general industry. This course teaches the basics of self-rescue as well as assisting a fall victim. Participants will expand their rescue skills as well as better understand the requirements of OSHA, ANSI & CSA with regard to rescue. Participants will be involved in practical hands-on work & should dress accordingly. This course involves both multi-media presentations & hands-on workshops. (Advance Rescue course also available)



## ARC FLASH

Hazard analysis, safety assessment, PPE selection & onsite training for electrical compliance.



## FIRST AID

Classroom courses cover a range of OSHA requirements, including training that teaches your employees the life-saving skills they need in first aid, CPR & the proper use of AEDs (defibrillators).



## CONFINED SPACE ENTRY & RESCUE

16 hour course; This advanced multi-media based course is designed for individuals responsible for confined space entry or for planning & supervising employees that work in confined spaces. The course provides a detailed look at confined space regulations, the typical hazards involved, & a variety of control measures. The session also includes a number of hands-on exercises focusing on rescue, equipment application, maintenance & inspection, as well as instrumentation calibration. This confined space course meets or exceeds OSHA 7300 requirements.



## CPR TRAINING

This course satisfies the OSHA Workplace First Aid Standard & effectively teaches how to respond promptly to a variety of potentially life-threatening emergencies. Students who successfully complete a skill test session receive a course completion card ensuring full compliance. Offered as classroom or online course.
